### PRESIDENT'S MESSAGE

#### Dear Members,

Looks like a busy 4Q ahead for appraisers across all disciplines! Did have a chance to enjoy a bit of a late summer lull, though. I actually took some time to purge old files and take a carload of bankers boxes from years gone by to the shredder/recycler. It got me thinking about the advances in technology that we have experienced in our field and in business as a whole. While part of me feels like the additional efficiencies are more than offset by higher volume, tighter deadlines and later nights, it is deeply gratifying to know that those bankers boxes that were cluttering my space will not be replaced now that I am on the path to a semi-paperless existence.

We kicked off our ASA-LA fall/winter season of Happy Hours with a visit from John Russell and Justin Kane from ASA-National for an update on government relations and how ASA leadership is serving the Chapters and membership. John is the Strategic Planning Officer for government relations and Justin Kane is the Chapter and Government Relations Specialist. Their roles include monitoring proposed federal as well as state legislation. Of particular interest was AB 948 in California (which was actually signed into law by Governor Newsom on September 28, 2021). With respect to the new California law, additional educational requirements have been added for applicants and those renewing their licenses, including curriculum addressing cultural competency. The "Fair Appraisal Act" (Section 11310.3 of the Business and Professions Code may be viewed in its entirety at AB948. It was also noted that the revisiting of Section 2704 of the Internal Revenue Code regarding discounts for fractional interests in family partnerships is expected to heat up once budget reconciliation is completed.


Other news included announcement of relocation to new National headquarters that will include classroom and conference space, as well as the much-anticipated launch of ASA-National's new website in 4Q 2021. And, to top it off, it was announced that the new Washington-Oregon-Montana chapter has been born, featuring a hybrid platform focusing on virtual participation but also including live events as well.

We here in traffic-choked SoCal will be keeping a close eye on this, since we do understand that in a profession that is driven by intense analysis and deadlines, driving across town (and county lines) to meetings and events can be challenging. While there is no substitute for face to face interaction, I believe we are seeing that virtual is likely here to stay in one form or another. Would love to hear your thoughts on the "hybrid model" and how it has shaped the way you envision your near-term and future professional life. #### **Appraisal Foundation News** The Appraiser Qualifications Board adopted changes to the Real Property Appraiser

Qualification Criteria that will take effect on January 1, 2022. Key changes to the criteria include: Synchronous courses will now be considered equivalent to in-classroom courses.

- Synchronous courses will no longer be required to have delivery mechanism approval under the AQB and an alternative course delivery mechanism approval for asynchronous courses was introduced.
- Hybrid courses must meet the requirements for each specific course delivery method (e.g., a course that is hybrid synchronous/asynchronous must meet the synchronous requirements for the synchronous portion of the course and the asynchronous requirements for the asynchronous portion of the course).
- Qualifying and continuing education courses may use remote proctoring, including biometric proctoring.
