# WHAT YOU MISSED... By Brooks Rice, ASA-LA Personal Property Chair

On July 31, 2012, the Los Angeles Chapter of the ASA hosted a wellreceived event at the Pasadena Museum of History, *Authentication and the Art Market: What Appraisers and Collectors Should Know.* The event featured speakers Debra Burchett-Lere, acting president and director of the Sam Francis Foundation and Christine Steiner, Art Attorney at Sheppard Mullin Richter & Hampton LLP.

Ms. Steiner's presentation focused on issues involving artists' foundations, authentication, the legal environment, and the recent disbanding of several artists' authentication boards due to costly lawsuits – including the 2011 disbanding of the Andy Warhol Art Authentication Board and the future disbanding of the Jean-Michel Basquiat Authentication Committee in September 2012. Ms. Burchett-Lere spoke about artist Sam Francis and the Foundation, the recent publication of the artists' catalogue raisonné, keeping catalogue raisonnés current for all artists, the function of artists' foundations, authentication, and the influence and impact these issues have had on the art market. The topics discussed were timely and were of great interest to the appraisers, collectors and other professionals in the art world who attended the event. Due to the popularity of the program, the speakers presented to a nearly sold out room with overflow seating.


