Legislature. The Legislature is in the last three weeks of the 2021-2022 Session, and there is a great amount of activity in wrapping up its bill load. On Thursday, 8/11, the Senate and Assembly Appropriations Committees heard 783 bills (killing about 1/4 of them), and there are about 1,200 total bills to be considered before adjournment on August 31. Among those, SB 1323 appears to be of interest for appraisers. The bill would create a new process within California's non-judicial foreclosure proceedings during which property could be sold through a multiple-listing service before the property is auctioned off, enabling the equity of the homeowner's property to be protected by allowing for the foreclosed home to be sold at or near its appraised value. Specifically relating to appraisers, the bill requires an appraisal of a foreclosed-on home to be conducted by a licensed neutral third-party appraiser. We are keeping an eye for other measures which may affect the appraisal industry (profession). We also look forward to collaborating with ASA's national representative John Russell regarding federal appraisal policies and how they impact California, our nation's most populous state. G. V. 
