Dear Members:

Our Chapter hired G. V. Ayers to fight SB 70. Here is his opposition letter. (Link to letter). The Bill is now stopped for 2017 but could be re-introduced in 2018. I believe the stopping is the direct result of Mr. Ayers' efforts on our behalf.

Steve Hjelmstrom and I attended a seminar put on by the Appraisal Foundation on February 24 in Torrance. The Appraisal Foundation is highly supportive of our ASA Chapter's position that there is no need for alternative standards in the State of California. Members of the Appraisal Foundation presented a report prepared by the Appraisal Sub-Committee. Significant in the report is that California is one of eighteen states whose Appraisal Regulatory Body has received a rating of 'Excellent' from the Appraisal Foundation.

ASA / USC 12th Annual Fair Value Conference

June 1: Ronald Tutor Campus Center at USC, Los Angeles (8:00am)

With the release of ASC 350, 805, 820 and 718 (among others), fair value estimates have become increasingly important elements of the accounting process. Consistent with the relative newness of this accounting guidance and the challenges developing fair value estimates, PCAOB inspection reports often note audit deficiencies involving fair value estimates. The SEC has commented publicly about concerns regarding valuations and a new appraisal certification, Certified in Entity and Intangible Valuations, is being rolled out to the valuation community.

In recognition of these concerns impacting financial statement preparers, accountants and appraisers, the American Society of Appraisers' and University of Southern California Leventhal School of Accounting's Twelfth Annual Fair Value conference will be held on Thursday, June 1, 2017 at the Ronald Tutor Conference center on the USC campus.

Although one of the conference organizers is a not-for-profit entity focused on appraisal education and certification, the conference proceedings will be of significant interest to financial executives and accountants. The conference will provide important updates on a range of fair value matters impacting financial reporting. Conference presenters include internationally recognized, senior accounting and valuation professionals at the Big 4 and other leading accounting firms and the PCAOB. Prior year's conferences have included representatives of the SEC, FASB and IASB among others.
